The NRF-W2 warrants were allocated to shareholders on October 1, 2025, in a total amount of 430,849,150 units.

Holders of warrants can obtain the form for expressing intent to exercise their rights to purchase additional ordinary shares from the company's authorized agent or download it from the company's website (<https://www.nrinstant.com/>). The expression of intent to exercise the rights to purchase additional ordinary shares must be submitted within the period specified in point 2 above.

4. Methods and procedures for exercising rights.

Holders of warrants or warrant substitutes can exercise their rights under the NRF-W2 warrants according to the following exercise procedures and guidelines:

4.1 Holders of warrants (both those held as physical warrants and those in the scripless system) who wish to exercise their right to purchase additional ordinary shares must comply with the conditions for notification of intent to exercise their rights. They must complete and submit the notification of intent within the specified period for notification of intent to exercise rights as follows:

- A) A completed and clearly filled-out form for exercising the right to purchase additional ordinary shares, signed by the holder of the warrant.
- B) Warrant certificate or substitute warrant certificate in the form prescribed by the Stock Exchange, with the transferor's signature on the back of the warrant holder, in the amount specified in the declaration of intent to exercise the rights.

If the warrant holder does not exercise their right to purchase all the ordinary shares and wishes to authorize another person to receive the new warrants for the unexercised warrants, the warrant holder must attach a letter of authorization signed by the warrant holder authorizing the other person to receive the new warrants for the unexercised warrants on their behalf.

- C) Proof of payment to the Company and/or its agent in response to the notification of intent to exercise the rights.

The holder of the warrant must pay the amount specified in the declaration of intent to exercise the right to purchase additional ordinary shares using one of the following methods:

- (1) Payment can be made by personal check or cashier's check that is clearable within Bangkok and its surrounding areas within 1 business day from the date of notification of intent to exercise the right each time. Personal checks, cashier's checks, and drafts must be dated no later than 25 September, 2026, and the notification of intent must be submitted

- Pay the total amount due and confirm the payment. Then, review the subscription information and save and/or print the payment confirmation as supporting documentation for the share subscription. (Subscriber information will be based solely on the Ref.1 and Ref.2 details from the payment.)
- When making payments via Mobile Banking, the account name must match the subscriber's name. We reserve the right to cancel the share subscription and will refund the subscription amount according to the refund method specified in the share subscription.
- Transfers via Mobile Banking must be made in a single transaction per subscription form (shareholder registration number).

5) Custodian:

Copy of the certificate of incorporation of the custodian and custodian appointment document together with copy of identification document of its authorized person(s) pursuant to Clause 1) or 2) above certified true copy by such authorized person(s) and notarized, within 6 months prior to that particular Exercise Date, by notary public of the country issuing such documents

If the warrant holder fails to provide the required supporting evidence for exercising their rights as mentioned above, the Company and/or its agent receiving the notification of intent to exercise the rights reserves the right to consider that the warrant holder does not wish to exercise their rights in that instance. However, the Company and/or its agent receiving the notification of intent to exercise the rights may, at its discretion, allow the warrant holder to exercise their rights as deemed appropriate.

4.3 The holder of the warrant shall be responsible for any stamp duty or other taxes (if any) as provided for in the Revenue Code or any other regulations or laws applicable to the exercise of the right to purchase ordinary shares under the warrant.

4.4 The number of units of warrants to be exercised for the purchase of additional ordinary shares must be a whole number only, with an exercise ratio of one warrant unit per one ordinary share, except where the exercise ratio is adjusted according to the adjustment conditions.

4.5 In each exercise of the warrant, the warrant holder must exercise their right to purchase at least 100 ordinary shares. The number of warrant units requested for exercise must be a whole number. However, if the warrant holder is entitled to purchase fewer than 100 ordinary shares, they must exercise the entire amount in a single transaction, except in the final exercise, where the warrant holder may exercise their right to purchase ordinary shares without a minimum number of shares specified.
